



Position Description

The Position Description (PD) provides a complete and accurate description of duties and responsibilities assigned to the position(s). To ensure maximum flexibility and efficiency, employees will be assigned additional duties as are deemed necessary by Santa Ana Golf Club, Inc.

1. GENERAL POSITION DESCRIPTION:

Under the direct supervision of the General Manager, the Golf Course Superintendent II is responsible for maintaining Santa Ana turf golf courses. The Golf Course Superintendent II will supervise and train the maintenance staff to provide golf course/playing conditions commensurate with the expectations of guests at a high-end destination resort and within established budgetary guidelines. Assist the Golf Course Superintendent II at Twin Warriors Golf Course in staff selection, employee reviews, training, and the scheduling processes. They will have responsibility for budgeting, purchasing, supervising all construction projects, including course changes and/or additions, as well as overall operations that will include irrigation operations, seasonal agronomic practices, and application of all pesticides, fertilizers, and soil conditioners. The Golf Course Superintendent II must possess interpersonal skills needed to effectively lead and motivate the maintenance team daily. Able to communicate effectively with the Pro Shop staff as it relates to daily operations, special events and maintenance schedule. Able to maintain and process timesheets for maintenance staff. Collaborate with all department heads in providing a cohesive product to our guests. Must be proficient in irrigation software. Maintain appropriate licensures, certifications, and professional memberships necessary. Maintain good relationships with vendors.

2. MINIMUM QUALIFICATIONS:

Associates degree or Bachelor's degree in Agronomy, Plant Science, or Turf Grass Management and 3-5 years of golf course maintenance experience or any combination of education and experience enough to perform the duties of the position. NM Pesticide Applicators License or ability to obtain such within 90 days of employment. Valid Driver's License with acceptable driving record for the past three years.

3. KNOWLEDGE REQUIRED:

- Knowledge of the equipment, tools, materials, methods and procedures used in golf course maintenance and construction.
- Knowledge of various soils, plants, grasses, shrubs, and trees used on golf courses, and the proper methods of planting, cultivating and maintaining them.
- Knowledge of the methods of diagnosing and treating diseased trees, shrubs, plants and grasses found on a golf course.
- Knowledge of various fertilizers and chemicals used in golf course maintenance and their proper applications.
- Knowledge of the methods and procedures used in the operation and maintenance of large area automated irrigation systems.
- Knowledge of basic mechanics and preventative maintenance of golf course maintenance equipment.
- Knowledge of pump house maintenance and operation.
- Knowledge of budgeting, purchasing, and fiscal responsibilities associated with the position.

4. SKILLS REQUIRED:

- Communicate proficiently with employees, supervisors and public using clear and professional language.
- Basic personal computer skills including Excel spreadsheets, Word programs, and irrigation software.
- Writing and typing skills.
- Submit payroll biweekly electronic timekeeping documents in a timely manner.

5. ABILITIES REQUIRED:

- Identify turf and other plant variations.
- Identify and safely operate hand tools and power equipment used in golf course maintenance.
- Operate and program and automated irrigation program both on site and using a two-way radio or smart phone.
- Perform basic math calculations (dispersion rates) necessary to ensure proper fertilizer and pesticide applications.
- Follow verbal and written instructions.
- Recognize safety hazards and apply proper safety precautions.
- Establish and maintain effective working relationships with peers, subordinates, leadership, and guests.
- Drive all company vehicles and equipment in a safe and courteous manner.
- Effectively assign and direct the work of all maintenance personnel.
- Stand, walk, kneel, climb, stoop, crouch, and reach for extended periods while performing maintenance work.
- Ability to work outdoors year-round in a variety of weather conditions.
- Frequently lift and carry objects such as tools and bags of fertilizer weighing up to 50 pounds; and to occasionally lift and carry with other associates' equipment such as mowers and the like weighing up to 100 pounds.

6. DUTIES AND RESONSIBILITIES:

- Responsible for the planning, layout, and maintenance of golf course properties, and in the supervision of the maintenance team.
- Collaborate with all department heads and the General Manager.
- Tour golf course and practice areas daily to assess course conditions and report any actionable findings, as necessary, to the General Manager in a timely manner.
- Maintain golf course putting greens, tees, fairways, roughs, bunkers, roads, paths, tee walk-ups, and related areas to the highest of standards.
- Tour all landscaped areas surrounding the clubhouse facilities, parking lots, golf school, and practice range to ensure the highest of standards.
- Perform seasonal aeration and topdressing of the entire golf course bi-annually, and as needed.
- Perform verti-cutting and light topdressing 1-2 times monthly during the months of March thru November.
- Perform planting and maintenance of trees, flowers, shrubs and grasses.
- Perform application of fertilizers, pesticides, and soil conditioners/amenities.
- Collaborates with maintenance staff, including the head mechanic, to maintain all equipment, both manual and power.
- Operate, maintain and repair irrigation and drainage systems.
- Collaborate with the Golf Course Superintendent II at Twin Warriors for all hiring, termination, and discipline of maintenance employees.
- Establish work standards and assist Twin Warriors Superintendent with employee evaluations.
- Monitor work sites to ensure compliance with established methods, guidelines, standards and procedures.
- Train personnel in correct and safe methods and procedures necessary to accomplish their goals and conduct monthly safety meetings.
- Establish a good rapport with team members and project a positive attitude.
- Lead by example and participate in workload as needed or required.
- Practice diplomacy with maintenance staff when making assignments, suggestions, or discussing workload and work performance.
- Interact and communicate with the golf shop staff as it relates to daily play, special events, and maintenance routines.
- Maintain a clean, safe work environment and immediately report accidents, injuries and unsafe work conditions to Human Resources. Complete the required paperwork in a timely fashion.
- Ensure uniform and personal appearance is clean and professional and follow SAGC dress codes and appearance policies.
- Maintain confidentiality of proprietary information and protect SAGC assets.
- Develop and maintain positive working relationships with all staff, and support SAGC to reach common goals.
- Perform other duties as assigned.
